Through minority stakes in the “Clear Companies,” we hold real-world assets tokenized as **D-Assets**—DBTC, DGOLD, DSILVER, DUSD, and others—tradable on **ClearExchange**, our real-time, cross-asset market.

Operating within Utah’s pioneering digital laws, we combine **regulatory clarity, sovereign identity (ClearID), and asset-backed receipts** into one unified infrastructure.

Our model generates seven compounding revenue streams—from equity growth to exchange fees and AI subscriptions—across a \$20-trillion digital transformation opportunity.

## 1. Vision & Overview

We’re listing under the proposed ticker **CLEAR** on Nasdaq, raising **\$100–\$250M**, and headquartered in **Park City, Utah**—the first state with a full legal framework for decentralized identity and assets.

## 2. What Makes Us Different

Most holding companies chase returns; **we build infrastructure**.

ClearHoldings owns **10–19% stakes** across “Clear Companies” and issues **decentralized, asset-backed receipts (D-Assets)**—each representing real, verifiable reserves:

- **DBTC** – Bitcoin
- **DGOLD / DSILVER** – precious metals
- **DUSD / DALA / UTC** – fiat and regional currencies

These are tradable on **ClearExchange**, our real-time, identity-anchored marketplace that allows instant, cross-asset clearing across currencies, commodities, equities, and crypto—without custodial risk or settlement delays.

- **ClearID** – Sovereign, verifiable identity using decentralized key management.

## 4. Market Opportunity


We are positioned at the intersection of multi-trillion-dollar markets:


